# What's involved in being a member of the Dunkeld Progress Association?

DPA Meetings take place at Sterling Place, Dunkeld Community Centre on the first Monday of each month at 7.30pm.

Agenda and Minutes are emailed to members. Members will also receive, by email updates and any relevant information. Meetings are open to all Dunkeld residents and businesses, but only DPA paid-up members can vote.

All members, and anyone who attends DPA meetings agree to adhere to the ground rules. These rules ensure all conversations are safe, inclusive and respectful.

#### How are decisions made?

The DPA has an executive group which operates in accordance with the model rules of incorporation (A003969OS).

Any Dunkeld resident or business owner with a 3294 postcode can raise relevant topics with a member of the DPA executive. Topics raised will be added to the next DPA Agenda for discussion.

As a democratic association, decisions require a vote of support by the membership. Once supported, how the decision should be enacted will be discussed. It is assumed that some tasks arising may be undertaken by DPA membership as well as the DPA executive.

'Executive members only' meetings may be held to develop ideas before bringing suggestions back to a public meeting for a decision.

Members of the DPA executive welcome feedback which enables them to do a better job. We are open to change; if the membership would like the DPA to evolve into something new, lets discuss it.

## How are priorities established?

The DPA recognises the recommendations identified in the Dunkeld Structure Plan (2012-2032) as a document which was developed by Southern Grampians Shire Council (SGSC) and informed by extensive community engagement.

The DPA will work with SGSC or any government or non-government agency to support the community engagement and advocacy process involved in the development of new plans or strategies which directly impact Dunkeld residents.

DPA priorities will be developed following a democratic process by DPA members.
